Served two terms

Jerome H. Arndt, MD
1992 – 1994
Baylor University Medical Center

During My Term:

- I worked with Dr. William Thompson to establish the ground work for a new organization, the APDR
- A plenary session using a “round – table” format during our first meeting was designed to discuss problems, expectations and priorities
- Information was summarized and serves as the basis for ad hoc committees and future actions



2nd President

Lee B. Talner, MD
1994 – 1995
University of Washington

During My Term:

- We focused on timing of the written and oral exam. The physics portion of the exam was moved from the 4th year.
- APDR solidified its relationship with A3CR2 by inviting chief resident and faculty leaders to present a summary of their concerns to APDR at the annual meeting
- APDR bylaws mandated that every third president should be from a non-university program



3rd President and Founder

William M. Thompson, MD
1995 – 1996
Duke University Medical Center

During My Term:

- APDR is still in “organizational mode” and membership continues to grow. The membership list was computerized. APDR page on the internet was developed.
- Facilitated collaboration between APDR and SCARD in order to increase communication on education and training
- We worked with the AUR on the annual program, and Radiology becomes attractive to other research and educational organizations

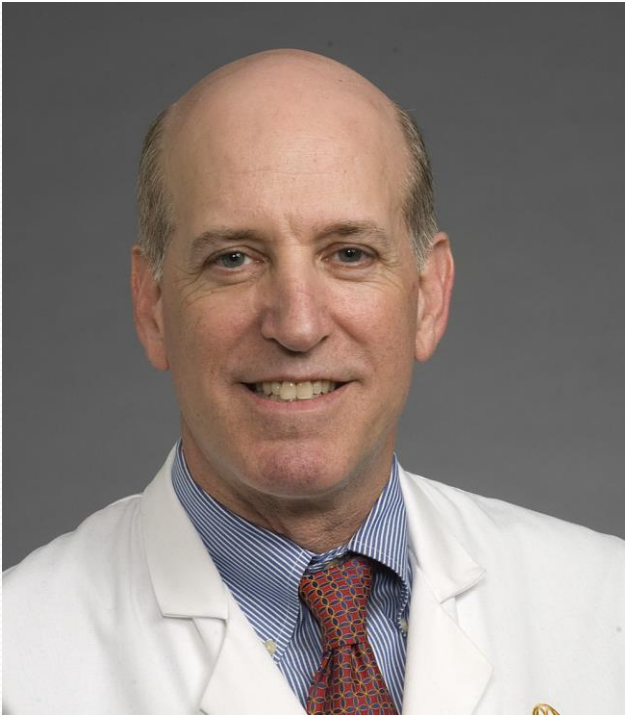


4th President

During My Term:

- Seventy percent of Radiology Residency Programs registered for ERAS
- APDR became a full sponsor of the Journal of Academic Radiology
- The APDR Achievement Award was created. The first winner was Jerome Ardnt.



5th President

1997 – 1998
Wake Forest University School of Medicine

During My Term:

- APDR endorsed the requirement for programs to give program directors protected time. This later became an RRC requirement to maintain accreditation.
- Restricted reimbursement for specialty training programs was of major concern and program directors left the meeting with better understanding of the issues and plans for improving the financing situation
- Emphasis was placed on recruiting more residency and fellowship program directors



6th President

During My Term:

- APDR creates a series of video tapes on non-interpretive skills. ACR agrees to fund and formalize the development of a program in education for these skills. Dr. Jannette Collins edits a series of manuscripts on the same material and these were published in the AJR.
- APDR listserv was created
- The first appointment of a resident to the Radiology RRC is established



7th President

Murray L. Janower, MD
1999 – 2000
St. Vincent's Hospital

During My Term:

- Curricula for residency training, and openings for residency and fellowship positions were posted on the APDR website
- Converted the annual survey from paper to electronic form
- Formally invited the APCR to become an affinity organization in APDR

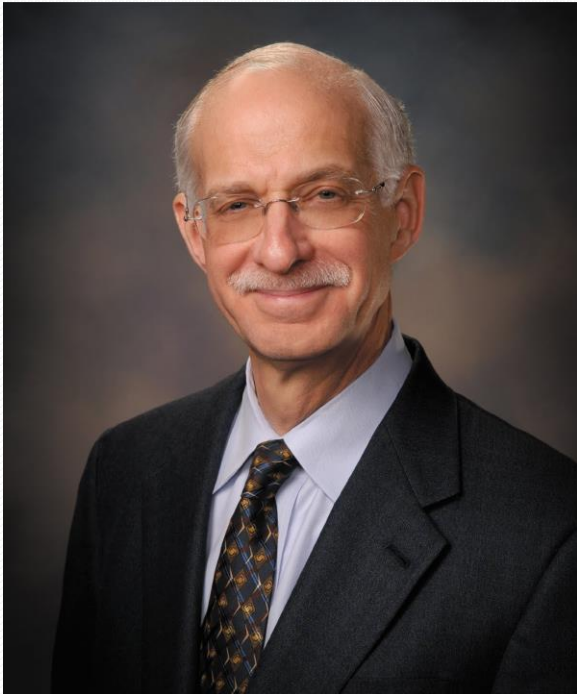


8th President

During My Term:

- APDR accepted APCR as a new membership category.
- ACGME required that a minimum of one day a week administrative time must be provided to program directors
- Board approved funding for visiting lecturers, and partnering with other societies financially to support educational programs

University of Oklahoma Health Science Center

During My Term:

- RSNA, ACR and APDR paid for the Program Directors Manual, edited by Drs. Jeannette Collins and Felix Chew
- Beverly Woods became the Deputy Editor for Academic Radiology, representing APDR
- Two additional video tapes on non-interpretative skills were developed by the ACR



10th President

During My Term:

- Residency Program Manual published by Jeannette Collins, MD as a supplement to Academic Radiology
- Fellowship match program for all ACGME accredited fellowships was implemented
- APDR developed a five year strategic plan

During My Term:

- APDR focused on the educational needs of small and large programs
- ACGME mandated core competencies in resident education
- The Strategic Alliance was developed to coordinate leadership among societies interested in education

During My Term:

- A major effort was made to attract more program directors
- Issues of interest to the fellowship program directors were included in the annual meeting program
- APDR asked SCARD to support their coordinators with funding for dues and attendance at the annual meeting

During My Term:

- Discussions took place at the ACR Intersociety Conference to restructure the radiology residency, the written and oral exam
- ABR began stressing the importance of Maintenance of Certification
- AAPM sponsored a forum to improve physics education. They planned to develop a curriculum and have their members create online physics education modules.



14th President

During My Term:

- A survey sent to program coordinators to determine their level of departmental and institution support resulted in changes in ACGME diagnostic radiology program requirements
- APDR collaborated with the ACR to develop online modules to teach the system-based practice competency
- ACGME required residents to have 12 months of training prior to taking independent call
- ACER was formed as part of the AUR alliance

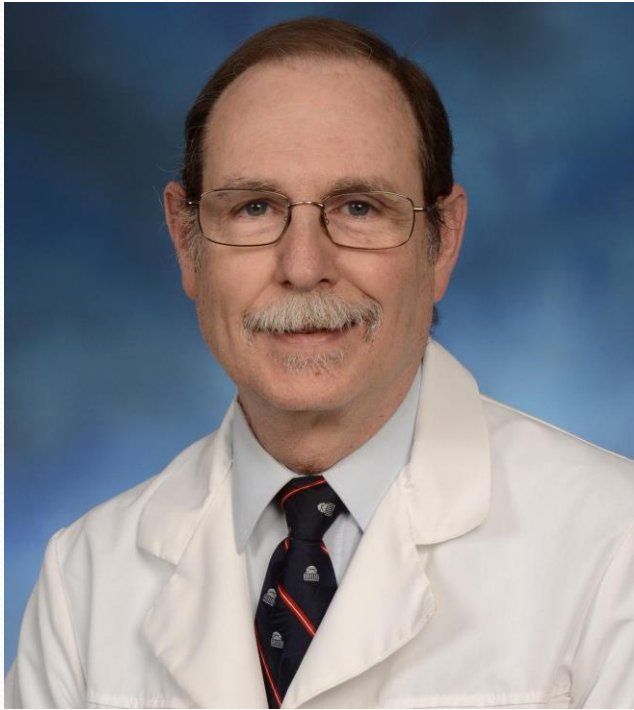

- ABR announced changes in board examination (Core exam at 36 months and Certifying exam 15 months after training)
- The board worked on changes proposed by the RRC, and two Ad Hoc committees were formed: Residency Restructuring and ABR Exam of the Future
- Continued working with the program coordinators on the tools and recognition they deserve

During My Term:

- The small programs/non-university programs committee was formed
- Worked with SCARD to develop the annual leadership session at the AUR
- APDR obtained input from all major radiology organizations to provide a unified response to the ACGME request for input IOM recommendation on resident duty hours

During My Term:

- ABR and ACR worked on the final restructuring plans for the board exams
- APDR drafted a new curriculum to meet the new standard and developed guidelines for transition to the new certification method
- APCR develops tools for Radiology TAGME certification exam. Eight APCR members become TAGME certified.
- The APDR continued to serve a major role in program training compliance, innovation and support for directors and coordinators

- Guidelines are created outlining the responsibilities and commitments for each of the standing and ad hoc committees

During My Term:

- ACGME announced a new requirement of a year of accredited US internship for all IMG and DO radiology resident candidates, and the start of the “Next Accreditation System” and Milestones Project
- New NRMP requirement of “all in or all out” went into effect
- The ABR Core Exam and the new IR/DR Dual Certificate were areas of strong interest and discussion
- The APDR endorsed the ACR/APDR/AMSER E-24 Project, a series of online lectures directed at residents and fellows to improve and assess teaching of medical students

During My Term:

- APDR provided input and guidance in the formation of the new IR residency training program

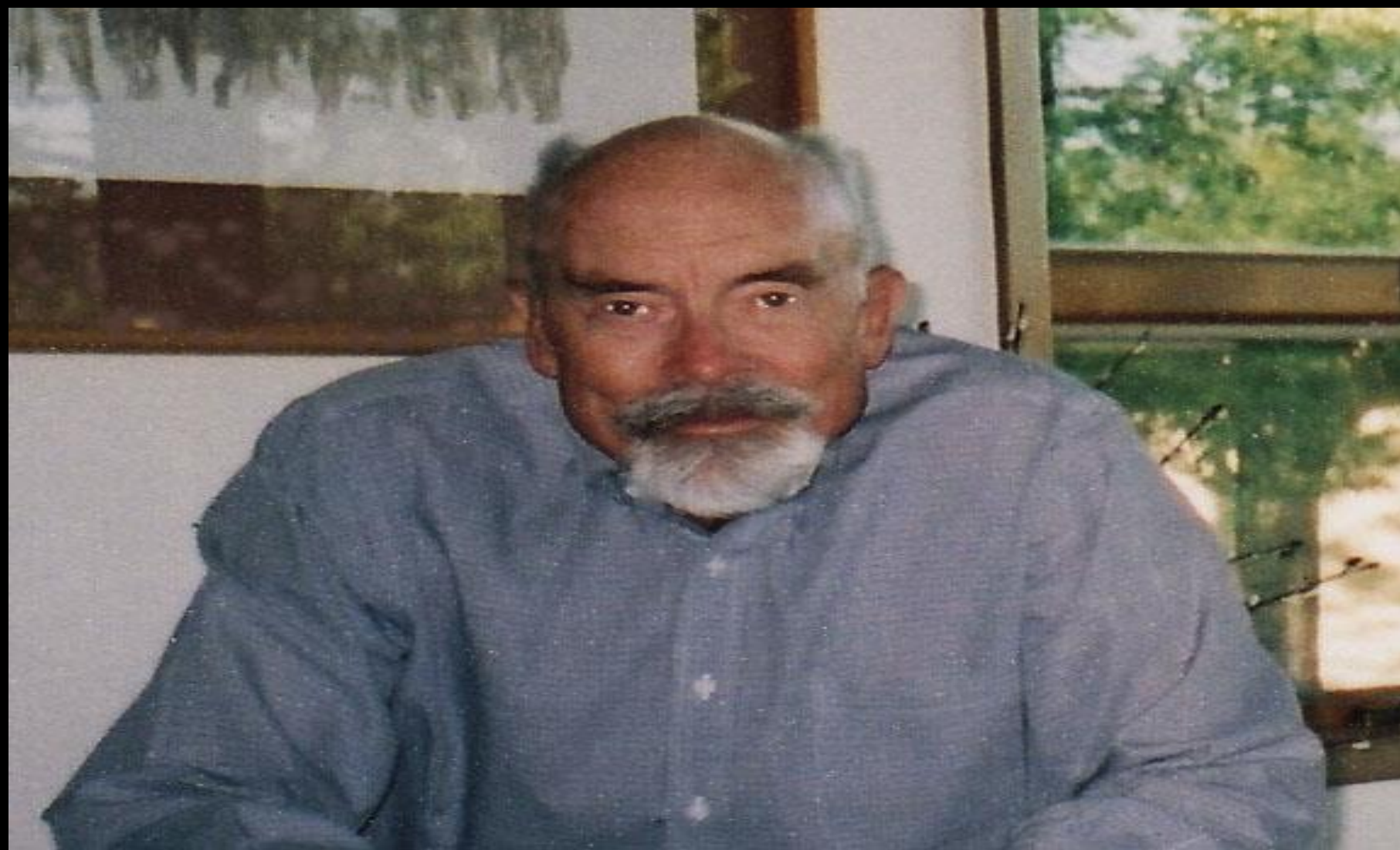
